What we know about you

When you visit our website, our Web server automatically records some general information about your visit, but does **not** recognise or record any *individual* information about you. The information we record and use for statistical purposes is:

- Your server address
- The date and time
- The pages accessed and documents downloaded
- The previous site visited
- The type of browser used

We can only identify you personally if you give us this information voluntarily.

We use a cookie to control pop-up windows, so that we don't annoy you with lots of pop-up windows every time you visit the site.

If you visit the site using one of our affiliates' links, we use a cookie to keep track of your visit, so that we can correctly pay the affiliate a commission if you make a purchase.

Your email address

We do **not** know your email address unless you give it to us. We only record your email address if you send us a message, either directly or by signing up for our newsletters or online courses. We will use it only internally within the organisation and will not disclose it to other organisations without your permission.

If you have given us your email address, but do not want to receive emails from us in the future, please let us know by emailing us at the address below or unsubscribing from an emailed link.

How we use this information

We use this information to improve the content of our Website, and analyse what pages people visit, and to keep in touch with you.

Who has access to your information?

We use this information internally and share it with others or organisations who need to know it as part of working with us in our normal business activities (e.g., sub-contractors, hiring leaders).

Some of the information (including health information) collected by us may be disclosed to employees or contractors of Beyond Ergo inside and outside of Australia. Security measures to safeguard client data include the use of a password and data protection tools. You consent to your information being disclosed to a destination outside Australia for this purpose, including but not limited to Cebu, Philippines.

We do **not** share your personal information with others except under these conditions, and we do **not** disclose or sell your personal information to others for use in mailing lists or databases.

Future Variations

If our information practices change at some time in the future, we will post the policy changes to our website to notify you of these changes and provide you with the ability to opt out of these new uses. If you are concerned about how your information is used, you should check our website periodically.

Corrections

Upon request, we'll tell you what information we have recorded about you. For your own protection, we generally ask you to make this request in writing, so that we can verify your identity (email is too easy to forge!)

If any of the information is incorrect, or you want us to remove all information about you, please contact us, and we'll amend it promptly.

In general, we value your privacy, and will only continue to correspond with you if either:

- You give us your email address or postal address for this express purpose (for example, if you sign up for our newsletters or online courses, or request information about our products and services); or
- We have an existing business relationship (for example, you have bought our products or services or connected with us on social media).
